

DRAGONFLY FARM LLC HORSE SHOW CONTRACT

Owner/Exhibitor”: Owner/Exhibitor means _____, who owns the horse or horses described on Exhibit A wishing to horse show.

“Horse”: Horse means the horse or horses referenced in Exhibit A.

“Horse Show Fees”: Horse Showing Fees means the fees charged by Operator to care for and train each Owner/Exhibitor at a given horse show. Owner/Exhibitors currently boarding the Horse at Dragonfly Farm in Northville are charged a discounted rate.

Daily Rate (Boarded Horses). Owner/Exhibitor shall pay Operator the sum of **\$55.00** per day for each boarded horse attending a Show. The Daily Rate shall be paid in full upon receipt of the invoice following the Show. The Daily Rate shall include professional training fees only.

Daily Rate (Non-Boarded Horses). Owner/Exhibitor shall pay Operator the sum of **\$75.00** per day for each non-boarded Horse attending a Show. A non-boarded horse is any horse not currently boarded at Dragonfly Farm in Northville, Michigan. The Daily Rate shall be paid in full upon receipt of the invoice following the Show. The Daily Rate shall include care and maintenance of the Horse as well as limited turnout (if available) and groom fees.

Load and Set Up Services. Owner/Exhibitor shall pay Operator the sum of **\$40.00** per show for packing and unpacking the trailer, setting up the Owner/Exhibitor’s stall and for setting up the tack and feed room.

Training Rides. Owner/Exhibitor shall pay Operator the sum of **\$50.00** for each Training Ride associated with the Show. All Training Rides shall be performed by Michelle Friedman of Dragonfly Farm LLC. Any Training Rides are separately charged.

Split Services. All Owner/Exhibitors shall split the costs of the following expenses on a per Horse basis: lodging for staff, gas mileage, feed, hay, tack/feed stalls, bedding and paddocks.

Partial Groom. Owner/Exhibitor shall pay **\$25.00** per day for groom services which include feedings, stall cleaning and turnout (if available). Additional Horse care services shall be separately and additionally charges and itemized. Note: All feeding and turnout is to be done by groom.

Full Groom. This service is available on request. The fee for this service is **\$100.00** per day (plus expenses).

Deposit. Any Exhibitor who wishes to show must pay a **\$100.00** deposit in advance by the posted dates on the Dragonfly Farm website in order to show. The deposit will be applied to the show bill and deducted accordingly.

Payment for All Services. Payment in full for all services is due upon receipt of the invoice by email. If the fee is paid in full within upon receipt of the email, no late fees shall be charged to the Owner. After 24 hours, unless other arrangements have been made, a late fee of **\$50** plus **\$10** per day shall accrue until payment in full is made. Any partial payments shall be applied

first to outstanding balances.

Health Certificate. All Owner/Exhibitors must provide a current Health Certificate to Operator as a condition of horse showing.

Administration of Medication. Under NO circumstances shall the Owner/Exhibitor administer any medication for the duration of the Show. All medication shall be administered by Michelle Friedman or under the direction of Michelle Friedman of Dragonfly Farm LLC. A breach of this provision shall be grounds for removal from the Show or other reasonable remedy to remove any and all responsibility from Dragonfly Farm LLC and Michelle Friedman. Pursuant to GR 404 of the USEF Rules, the Trainer is responsible and accountable for the condition of the horse/pony and for compliance with the doping rules. As such, sanctions are imposed against the trainer for any proven doping violations. Please see the full text of that rule at [GR404 Responsibility and Accountability of Trainers](#)
